

I. Sažetak

Analiza medija popraćenosti 3. Konferencije Mreže pravde u BiH „Ljudska prava i pravosuđe u BiH“, održane 26.04.2012. u Sarajevu pokazuje da je bilo ukupno 13 medijskih objava.

Najviše medijskih objava zabilježeno je na elektronskim medijima, TV (5) i radio (1), zatim 4 objave na internet portalima i dvije objave u štampanim medijima.



Konferenciji za medije, koja je održana isti dan kao i Konferencija „Ljudska prava i pravosuđe“, prisustovalo je 12 predstavnika vodećih medija u BiH. Poziv za učešće na Konferenciju, pored web stranice Mreže pravde, objavljen je i na 5 web stranica mreža ne-vladinih organizacija i nekoliko web portala.

Efficiency for Judicial Sector

**A report titled "Human rights and judiciary in Bosnia and Herzegovina"
prepared by the Justice Network offers recommendations to Bosnian institutions
for the establishment of more efficient judicial system**

A second "Human rights and judiciary in Bosnia and Herzegovina" report on implementation of recommendations in the field of judiciary contained in the Universal period review of the Human Rights Council of the United Nations, covering the period from 2011 to 2012, has been issued on the basis of a report produced by a working group of the Justice Network, comprising of 57 NGOs in Bosnia and Herzegovina. As the UN bodies lack capacities to directly monitor the state of human rights in member countries, it has become obvious that NGOs play an important role in case a member country fails to be sufficiently self-critical. Some of the key roles of NGOs include monitoring and reporting on the protection of human rights and advocating to local authorities and international organizations for the better protection of human rights. The goal of the mentioned report is to provide an insight into the implementation of recommendations given by the UN Human Rights Council, which were made through the Universal Period Review process. It mainly focuses on judicial system and includes only the recommendations that have been identified as crucial for improvement of the judicial sector in Bosnia and Herzegovina. The report consists of three parts: the efficient protection of human rights, independency of judiciary and transitional justice. The institutions that are in charge of implementing the recommendations in Bosnia and Herzegovina include: the Ministry of Justice of Bosnia and Herzegovina, entity ministries, Ministry of Human Rights and Refugees of Bosnia and Herzegovina, Parliamentary Assembly of Bosnia and Herzegovina and entity parliaments, Court of Bosnia and Herzegovina, as well as lower courts, state and entity prosecutions, and the Supervisory body for monitoring of implementation of the State War Crimes Processing Strategy. In its report on progress made in Bosnia and Herzegovina in 2011, the European Commission mentions the processing of war rape cases and other forms of sexual violence. It points out that further efforts are needed in this area, which is closely related to the adequate protection of witnesses. The European Commission also expects that a national strategy for assistance to war rape

victims and victims of other forms of sexual violence will be adopted. Recommendations given to the Ministry of Human Rights refer to the improvement of the status of women, victims of war rape, sexual abuse and torture in Bosnia and Herzegovina, as well as the need to create a central database of victims of war rape and other forms of sexual abuse.

It has been recommended to ministries of justice that they harmonize the definitions of sexual violence as a war crime in the Criminal Code of Bosnia and Herzegovina with the international legislation and practices of the International Criminal Tribunal for the former

Yugoslavia, harmonize the legislation dealing with acquiring the status of victims of war rape and other forms of sexual violence in Bosnia and Herzegovina and solve the reparation to victims issue. It has been recommended to courts and prosecutions to improve the processing of sexual violence in armed conflicts, which particularly refers to entity and cantonal courts, by increasing the number of judges and prosecutors who have been specifically trained for dealing with such cases, and ensure better conditions for the more efficient protection of witnesses, particularly those testifying before entity and cantonal courts.

Presidency Okays 2012 Budget, with Exceptions

BiH Presidency has adopted the 2012 budget proposed last week but has not agreed on cuts to civil service salaries on the grounds that this is unfair if it does not fall for elected officials too. At a session in Sarajevo, the Presidency adopted the 2012 budget worth some 485 million euro, as suggested last week by the Council of Ministers. But the Presidency said salaries of state servants cannot be lowered, as the Council asked, as the Constitution says the salaries of elected officials cannot be cut during their mandates so the constitution needs changing first. Ministers who asked lower salaries and parliament members, who are due to support ministers' suggestions, are protected during their mandates, which the Presidency saw as unfair and that so said an article of the Constitution should change to allow lowering salaries of elected officials too. The Presidency also said there should be no new hiring in the state-level administration in this year. Two out of three members of the Presidency supported the budget while the Bosniak member, Bakir Izetbegovic, voted against. Izetbegovic said that although he voted against the budget, he is satisfied that they agreed some decisions on budget cuts and hopes that the state parliament will support them.

"It is good that there will no lowering salaries for now because that's not the way to cut the budget," Izetbegovic said

explaining that some of his own proposals for budget cuts, which were adopted, will change the way offices are rented, which cost millions of Bosnian marks a year. Zeljko Komsic, Croat member of the Presidency, last week said he did not back lowering salaries of state servants if salaries of parliamentarians or ministers are not lowered too. He referred to the decision of the Council of Ministers, adopted along with the budget last week, that salaries of state servants should fall by 4.5 per cent. Another proposal adopted by the Presidency is to abolish all reimbursements for officials who participate in parliamentary commissions. Izetbegovic said he believes the State Parliament will not change immediately the article of the Constitution in question, so salaries will not fall for anyone this year, according to him.

Besides the amount of 485 million for financing state institutions, the final budget also includes 227 million euro to pay off loans that the country took from various foreign financiers.

After learning that the Presidency had adopted the 2012 budget, which also includes money for their unpaid pensions, ex-soldiers protesting in front of the state government in Sarajevo called off their sleep-in protest after a month, but warned they will be back on the day that lawmakers finally decide the matter.
